- 2. Josephine Hancock, Stakeholder: Filed a grievance letter from an incident that happened where Lilliana Sanchez bullied me. DONE 60 days to resolve the issue or forward the issue. Bullying is unacceptable. We want more community involvement, not less because of bullying.
- 3. Ginger Henry: I am here to acknowledge that Mrs. Hancock is correct.
- 4. Luke Vella: The stabbing is unacceptable in our community. We should hold a rally. LAPD was called on me because I spoke out of turn. Lillian Sanchez came up with a camera to provoke me.
- 5. Census Count is coming, they are hiring 1000s of people for that.
- **5. Public Official and Community Representative Announcements**: Officer Caloca and Contreras, LAPD Senior Leads in the area. 25% crime reduction in the area down from last year. We have had some out of normal, high priority incidents. The information you have on the

stabbing is everything that's been released. We know what happened, who did it, everyone's in custody. Our issue is what ties them back to this community and how do we get rid of that. Aside from that, we haven't had any other issues. Community input helped wrap this up very quick. Question: Was that MS13? A: No, it was Hazzard game, they operate elsewhere normally. Question: Last week I was told there was no gang activity and I refute that... Council Interjected: Dana, this is not the time for this....

Officer's answer: If there's any time to call us, please call 911. If it's an ongoing issue that requires long term assistance call me personally. Send photos of any vandalism to 311. Neighborhood watch 3rd Monday of every Monday at Starbucks on Sunland. We have all day to answer questions.

- 2. Arturo Garcia: Earth day LA tree planting event. You can get a free fruit shade and tree. There's going to be a home composting workshop with LA sanitation. Freeway service patrol, 511 a tow truck will get you into a safer location and give you a gallon of gas. Brief Legislative update, AB 1313 Post secondary schools prohibited from withholding transcripts due to debt.
- 3. Kelly Gomez School Board, District 6: I have been to every single school I represent. I'm with 2 principles tonight. An upcoming measure could impact students. Measure EE will bring critical resources to our students. California is 44th in the nation in per pupil spending. EE will make critical investments in education. 16c tax per sf of building for the next 12 years. Presents certificate to the Sunland Tujunga neighborhood council for support. (Group photo takes place)
- 4. Principal Sosie Karlian: I am proud new principal of Mountain View Elementary. We are often making choices between funding a school nurse or a psychiatric worker. With Measure E, we would have all the additional support we need.
- 5. Principal Arturo Barcinas. Verdugo Hills principal for 4 years. Our best intervention for kids is to lower class sizes. That is the number 1 priority. Measure EE would be beneficial for this. We need more emotional help as well for our students. We need mental health and support services for our students.

Question: We've had a youth council in the past, is this something we can collaborate on to show students how neighborhood councils work. A: Absolutely. I'm all for it.

Dana Stangel: What we are missing is that parent/volunteer link, you find me that and we are golden.

Public Comment: Expressed concern about fixed incomes and more taxes.

Kelly Gomez: This measure cannot be used on anything wasteful such as paying off lawsuits. It's in the language of the measure. 65 older seniors are exempt. Based on state law, we must have 3 years of balanced budgets. If we are impacted by a recession and we don't plan for it, it could be devastating with thousands of layoffs like what happened in 2008.

- 5. Dominique Vitti from Councilman Monica Rodriguez office: 1st update is that city council voted yesterday for an additional \$500,000 in for CAL fire for damage. We are now hiring again giving priority to veterans and locals. Our office recently hosted a massive community clean up on La Tuna Canyon. It's a constant struggle with that street. Draining improvements at a local park. Homeless connect day on May 16th. We recently created a 1 pager for homeless, this handout has information on how to report encampments.
