Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period however, the issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Board.

<u>AB 361 Updates</u>: Public comment cannot be required to be submitted in advance of the meeting, only real-time public comment is required. If there are any broadcasting interruptions that prevent the public from observing or hearing the meeting, the meeting must be recessed or adjourned. If members of the public are unable to provide public comment or be heard due to issues within the Sunland-Tujunga Neighborhood Council's control, the meeting must be recessed or adjourned.

The Neighborhood Council system enables meaningful civic participation for all Angelenos and serves as a voice for improving government responsiveness to local communities and their needs. We are an advisory body to the City of Los Angeles, comprised of stakeholder volunteers who are devoted to the mission of improving our communities.

Discussion/Possible Action: That the Sunland-Tujunga Neighborhood Council requests that the City Council through their Legislative process requests that the State of California mandates that all new EVs have their charge ports located on the passenger side of the vehicle. Many EVs currently have the charge port located on the driver's side of the vehicle and when they are connected to a charging station on the street, the charging cable protrudes into the right of way causing a potential obstacle for bicyclists and other traffic. The State of California should also mandate that EVs have an interlock installed that will not allow the EV to move if the charging cable is in the charging port.
