

CITY OF LOS ANGELES ENVIRONMENTAL NOTICES

Notice is hereby given to the general public of the availability for public review and comment on the following environmental documents. Please call the telephone number listed in each particular item for information regarding the location where the document is available for the review and where written comments must be addressed. CD indicates the City Council District. The publication is intended to serve as our Notice of Intent to adopt the following Proposed Mitigated Negative Declaration (MND) or Negative Declaration (ND).

NG-15-293-BE-Negative Declaration/Initial Study: The purpose of the project is the long-term clearing, cleaning, maintaining, repairing, and restoring of Oro Vista Avenue and associated berms, swales, and shoulders that are located within the Big Tujunga Wash. At the end of the Southern California rainy season (October to April), and/or after major storms (December to March), and/or after a major release of water from the Big Tujunga Dam, the City would remove accumulated sediments (i.e. sands, mud, boulders, etc.) and debris (i.e., trash, logs, trees, brush, etc.) that block the flow of waters under the bridge, through the culverts, or over the Arizona Crossing, upstream and downstream of Oro Vista Avenue. All work will be accomplished shortly after major flows have ceased and most all ground cover would have been removed due to water flows and scouring. The project will recreate berms and swales in Big Tujunga Wash as needed to restore it to its pre-storm flow, pre-storm season, or pre-discharge of waters from Big Tujunga Dam, (i.e., under bridge, through culverts, or over Arizona Crossing). There will be no new stream channelization or relocation. The project site is in the Sunland - Tujunga - Shadow Hills - Lake View Terrace - East La Tuna Canyon Community Plan Area and in Council District 7. NG-15-294-BE- Mitigated Negative Declaration/Initial Study: The proposed project consists of the widening of Alameda Street between Harry Bridges Boulevard and Anaheim Street to add two lanes of through traffic, one each way; intersection improvements to East 'E' Street and Eubanks Avenue; right-turn lane from Alameda Street onto Anaheim Street; railroad crossing improvements at East 'E' Street, Eubanks Avenue, and Harry Bridges Boulevard; storm drain improvements along Alameda Street, relocation and installation of utilities (i.e., power lines, fire hydrants, street lights, traffic lights, etc.); and landscaping and wall/fence improvements. The project site is in the Wilmington-Harbor City Community Plan Area and in Council District 15.
