GENERAL BOARD MEETING

Item 1.

A-B. **Call to Order and Welcome, President Sanchez**—Meeting called to order, Pledge of Allegiance, Roll Call --Meeting quorum met.

C. **Meeting Protocols Reminder by Secretary Cindy Cleghorn** – Welcome. This meeting will be recorded for records purposes. Treasurer Capps will be the timer. Meeting attendees will be muted, use raise hand feature to comment on Zoom or dial *9 on phone. Comments by public limited to two minutes. We are transitioning into this new environment. Please provide grace and follow code of civility. Please address comments to the Board and not to individual members. Board members generally do not respond to public comments. Board members should mute if not speaking or voting.

D. **Board Members Eligible to Vote / Member Training** – All Board Members Eligible. For Land Use members mandatory Planning 101 training deadline is December 16th, there are two remaining sessions per the links posted on the agenda.

E. **Board Member Conflicts** – Secretary Cleghorn will recuse herself from voting on Agenda Item 16.

Item 2. President's Report: President Sanchez notes that according to the Los Angeles County Dept. of Health, there have been 1,871 Covid 19 cases in Sunland Tujunga and 49 deaths, including the recent passing of Sargent Fred Cueto. LAPD, Foothill Division. President Sanchez requests a moment of silence for those in the community who have lost loved ones to Covid 19.

There are 2 Group Representative vacancies on the STNC board. Qualifications for seat read into record. Anyone interested in these positions should apply by December 30th.

To accommodate the busy schedules of U.S. Representative Schiff, on duty police officers and other speakers, some agenda items will be taken out of order.

Item 7 (partial) Report by SLO Caloca, LAPD -- The passing of Sargent Cueto, was a great loss for the Foothill Division and the community. He went to Verdugo Hills High School. Unfortunately there has been a 25% increase in crime overall and a 100% increase in robbery in Tujunga, it was at 8 last year and is now at 16. This is due to a combination of factors. Always be aware of your surroundings and avoid flashing expensive jewelry. There were also a number of local business burglaries, taking advantage of businesses closed due to Covid 19 or for the Thanksgiving holiday. Even though the laws are changing hopefully the crime stats will plateau if neighbors look out for each other and we help by locking our cars and hiding valuables.

She has received several calls about the camp in front of the Tujunga library. This individual has been offered services through CD 7, but cannot be forced to move. Hopefully the service providers can help him.

Item 4. STNC Board Elections - APRIL 20, 2021 - City Clerk Admin: Nathan Singh (invited)

Secretary Cleghorn notes that Nathan Singh was not able to attend tonight's meeting but can come to the January meeting. Looking forward to the Elections Committee being able to give a presentation at the January Board Meeting.

Item 3. Presentation by Congressman Adam Schiff—President Sanchez welcomes the Congressman and thanks him for his support for this area by opposing high speed rail in the Angeles National Forest, writing a letter opposing the proposed Canyon Park Development, and expanding the lands preserved for the Rim of the Valley Corridor to over 191,000 acres.

Adam Schiff – thank you for inviting me to your meeting and for your hours of volunteer service; thank you Officer Caloca for your public service. Congress is in session now with two major priorities before holiday recess: 1) Pass a funding bill to avoid another federal government shutdown; 2) Pass another Covid relief bill. He is in favor of the bi-partisan compromise with \$300 enhancement of unemployment and extending PPE loans. He supported extending unemployment benefits to non-traditional contract workers and would like to see it expanded to those who have mixed income, both contract and traditional. There is some good news with the rapid development of 95% effective Covid 19 vaccines. This is a remarkable scientific achievement. These vaccines will start being available to front line workers in the next two weeks and to the general public sometime in the Summer of 2021. Until then we need to help families and the homeless get through this difficult time.

Q&A: (The public's questions were submitted in writing and pre-reviewed by the Congressman; Board members will be limited to 1 question)

Q: Will the government be using the National Guard to distribute the vaccine?

A: Yes, the National Guard could be used for this if needed; this would be up to each state. The military is involved in Operation Warp Speed to get the vaccine to first responders. The state and federal governments are cooperating in vaccine distribution. Thinks there is agreement that those who work in hospitals and rest homes and those living in residential care facilities will be first, the elderly and those with compromised health issues second.

Q: Do you support an independent Artsaka?

A: He was in support of an independent Artsaka, but this would have required the current administration to pressure Azerbaijan and Turkey and warn of serious consequences for their continued aggression. Unfortunately this did not happen so Armenia was forced into an unsustainable agreement. The more urgent task now is to revive the Minsk Group and make sure those displaced by this conflict can return home safely. He is also concerned that the current situation could allow Azerbaijan to have a stranglehold on Armenia, including control of their water supply.

Q: What is your plan for a path to citizenship for those on DACA? She has some talented students subject to DACA who cannot travel abroad for exchange study due to their immigration status. Are there any bills in the works?

A: Thank you for your service as a teacher. The good news is a court decision struck down the Trump administration's efforts to repeal the DACA program. He understands this is not a permanent solution. He does not know if this will help her students who want to participate in the exchange program. He was a co-sponsor of the Dream Act which he will re-introduce next year. What happens next depends on who controls the Senate. The current Senate Majority Leader, Mitch McConnell has not been supportive of this bill.

Q: Will anything be done to hold President Trump accountable for his criminal activities which were ignored by a majority of Republicans in Congress?

A: Has been active on this issue. The Protecting Our Democracy Act would expedite the process for congressional subpoenas that need court review, strengthen congressional oversight, reform the pardon system to keep it from being used as an incentive for those covering up wrongdoing, amend the Hatch Act to prohibit using public facilities such as the White House for campaign activities and protect those who testify regarding misconduct from retaliation. Few of his Republican colleges even acknowledge that Biden won the presidential election, so not sure how much can be done at this point.

Q: By member Khanjian – Thank you for your work on behalf of Artsaka. Do you think there will be any mandatory Covid 19 legislation?

A: Does not think Covid 19 vaccination will be mandatory given the opposition to even a national mask mandate. Some school districts may require it for in person school attendance unless there is a medical reason why a student cannot be vaccinated.

Q: By Member von Gunten – Is concerned about price gouging during the pandemic, prices for some items at the grocery store have doubled.

A: This is a recurrent issue during any time of product scarcity; it is difficult to trace the cause when there are complex supply chains. Thinks the shortages are better than before. This is usually a state issue.

Q: Is anything being done to help the restaurants who were shut down again despite following all the protocol for outdoor dining? Saw a video of a restaurant owner crying because her outdoor dining was shut down when a movie shoot had a much larger outdoor dining area set up in the same parking lot.

A: Understands that restaurants are under incredible strain due to Covid second only to the live performance sector. He agrees that rules should be equitable and applied equally to all business sectors. Hopes that congress will pass a bill with more PPE assistance with more flexibility to help businesses survive and not just cover payrolls. The State of California has 500 million available for small business and there are also other county and city relief programs. He is very sorry for the hardship suffered by his constituents working in this industry. Feel free to call his office at (818) 450-2900 if you need assistance with an aid application.

Item 7. Representative Announcements and Reports (continued)

Caroline Menjivar, Mayor's East Valley Representative – The City has a program for those who lost jobs in the restaurant industry, it is a one-time \$800 grant for \$4,000 people. You must live in the City of Los Angeles, but immigration status is not considered. More information is on the website: corona.virus.la/serve Friday is the deadline to apply. Sadly the East Valley is one of the City's most active Covid 19 areas with 25% of cases. There are testing centers this week in Van Nuys and Sun Valley no appointment needed. There is going to be a holiday giveaway in Sylmar this Saturday the 12th from 9 to 2.

Vickere Murphy, State Senator Anthony Portantino's Office – They are continuing to receive queries about problems with stalled EDD claims and fraudulent claims, email her office if you are having these problems. The Senator is going to try again to get something on the ballot to raise funds for wildfire protection and drought resilience. He is also working on a measure to incentivize cities to repurpose unused retail space for affordable housing. Their office is still working virtually.

Carmina Nacorda, LAUSD Local District Northeast, Sunland Tujunga Community of Schools. Would like to introduce self to the community. This community of schools includes all 7 elementary schools and the middle and high schools for our area as well as the Pinewood Early Ed Center. The LAUSD is planning to return to campus learning as soon as it is safe.

Eve Sinclair, Area Director for Councilwoman Monica Rodriguez –

Oro Vista Flood Control Project: It has been determined that LA Sanitation will be responsible for the design of this project which is going to bid in early January / February. The public meetings will begin after the contractor is selected.

North Valley City Hall This building was built in 1957 and is having a major renovation with new windows, floors, ceiling, security and sound systems. The improvements will soon be finished and the building will probably be available for public meetings once it is safe to again hold public meetings.

Operation Bright Spot along Foothill Blvd will return in March and April of 2021 to maintain the improved conditions. Until then call 311 for dumping or other problems

New lighting on Commerce St. will be installed between Valmont and Summitrose.

The Alternative Learning Center at Sunland Park is funded until January. The class is not full with a wait list of 10 more children.

Homeless Camp at Library – Street services cleaned this area yesterday. They do not have the power to make anyone move against their will. The CARE team visits Sunland Tujunga twice a week and this camp is on their radar.

Q&A:

By President Sanchez: There is a traffic jam at Tujunga Canyon Blvd /Haines Canyon every Wednesday due to people waiting to get food at the Methodist Church.

A: The LADOT does have enforcement working at this food drive, a precaution taken after the unfortunate accident in Sylmar. They are working on getting LADOT to re-direct through traffic

By Member von Gunten: Thanks for getting sanitation to clean up the mess by the library. He was contracted by a resident on Oro Vista who was concerned the Measure W project does not extend to the most impacted area.

A: The stretch of road that regularly floods is from Wyngate to Sunland Elementary. The constituent should email her about her concerns.

By VP Grant -- Any news on using NVCH as a location for the Neighborhood Council Elections ballot drop box?

A: This property is managed by the construction co. until the remodel is completed. She will let VP Grant know when they get control of the facility back.

By Member Potter – Will the lighting project on Commerce trigger a tax increase?

A: No. This is not an assessment district project.

Gibson Nyambura, DONE Rep –_The NC elections for Area 1 which includes Sunland Tujunga are coming soon. There is going to be a webinar on how to do election outreach during the pandemic on Monday Dec. 14th at 6pm. He is handling 2 other NC meetings tonight so if there are any issues, please reach out.

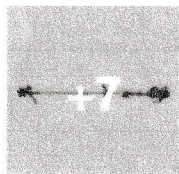

GRIEVANCE-PROCESS:

The Department reviews all Grievances to determine whether the Grievance conforms to the Grievance Policy in accordance with Ordinance No. 183487 (May 3, 2015) – Adding Section 22.818 to the Los Angeles Administrative Code (LAAC). Upon a determination that a Grievance conforms to the Policy, the Department certifies the Grievance and notifies the affected Neighborhood Council that the Grievance may proceed through the Grievance process established herein. If a determination is made that the grievance has merit, a notification is sent to the Neighborhood Council in question describing the suggested remedy.

Dear, Sunland-Tujunga Neighborhood Council:

The Neighborhood Council Grievance process is, in general, authorized to address alleged violations of the Neighborhood Council's rules, Los Angeles City ordinances regarding the Neighborhood Council system, Neighborhood Council funding rules from the City Clerk, or policies of the Department of Neighborhood Empowerment or Board of Neighborhood Commissioners (BONC). The allegations outlined in Grievance #265 are considered to be within the jurisdiction of the grievance process. As such, this letter serves as notification that we have certified the grievance. The grievance will be processed in accordance with the Ordinance.

Pursuant to the Grievance Policy, the following steps should be done in preparation for a Regional Grievance Hearing should the grievance not be resolved by the Sunland-Tujunga Neighborhood Council.

- The Neighborhood Council will have the opportunity to, within 60 days from the date of this letter, to agendaize and discuss the grievance in order to prepare for their presentation to the Regional Grievance Panel, which will be assembled no later than 90 days. If it chooses, the Neighborhood Council may consider, as a body, adopting a possible remedy that could satisfy the grievance. If accepted by the grievant, the matter could avoid having the matter forwarded to a Regional Grievance Panel. The authorized Representative will inform the department of any action via the [Grievance Response Form](#).
- The NC can choose to waive the matter and not consider the grievance, but by doing this, the NC will be waiving the opportunity to consider the matter and adopting a possible remedy collectively, as a body, that could satisfy the grievance and/or make a decision on what the authorized representative should say to address the panel at the hearing.

- Here's sample text of how the matter should be agendized, "Discussion and Possible action relative to the Sunland-Tujunga Board responding to Grievance #265 and, to authorize a PRNC Board Member as the designated representative authorized to speak on behalf of the Board at the Regional Grievance Panel Hearing for Grievance #265."
- The Department recommends giving consideration to forming an ad hoc committee of the board to address the regional grievance and prepare recommendations and possible action for board approval. All other procedures prescribed in your bylaws for the discussion and possible action of the board should be followed.
- After Board discussion and action, the authorized representative responds back to the Department via the Grievance Response Form and can include up to three witness statements if applicable.
- If the grievance is not resolved, the matter will be directed to a Regional Grievance Panel for consideration. The only documents that will be accepted and considered at the hearing will be the Grievance, the Grievance Response Form, and up to three witness statements for each side if applicable.
- The Department may convene a Regional Grievance Panel Hearing no later than 90 days if the neighborhood council discussed the matter and did not provide a possible remedy, or, the neighborhood council fails to take action within the allotted 60 day time frame, or, waives hearing the matter.
- At the Regional Grievance Hearing, each side will have 10 minutes to speak for opening remarks, after that, each side will have five minutes for a rebuttal, followed by deliberation by the panel.
- The only documents that will be accepted and considered at the hearing will be the Grievance, the Grievance Response Form, and up to three witness statements for each side if applicable.
- Notices regarding the Regional Grievance Panel will be sent to neighborhood council authorized representative via email to the email address that is provided to us in Grievance Response Form.
